- 1. Apologies for Absence. Councillor Ian Mitchell, Councillor Peter Champness, PCSO Steve Cocks
- **2. Chairman's Welcome and Public Participation.** KB welcomed the councillors to the meeting, there was no public participation.
- 3. To receive minutes of Annual Parish Meeting 2017 (Approved at the July 2017 Parish Council meeting) JS proposed the minutes were of a true account seconded by PR with all in favour.

New Councillor Stephanie Chapman has now joined us leaving all vacancies filled. The branches on Ethy Hill have finally had a start made on them as this has been an ongoing issue for some time. The gulleys and drains have also been cleared between Waterlake and Busmaughan Cross, the area by the stepping stones has also been cleared and the bench given a new lease of life. The continuous flooding of the road at Hogsmoor is still ongoing. And finally, the snow plan had been utilised, as the salt had been sitting for some time it had deteriorated somewhat therefore needs to be refreshed ready for the next cold spell.
- 5. Devon and Cornwall Police Report. From 01/03/18 30/04/18 there were four crimes, 3 at Bodmin Parkway Station and a theft from a motor vehicle which has been detected. Numerous patrols have been conducted around the parish and all was found to be in order.
- **6. Cornwall Councillors Annual Report.** Councillor Colin Martin spoke of his work over the last 12 months and has complied a Newsletter and a report on Health and Social Care, attached.
