

## Minutes of the meeting of ST WINNOW PARISH COUNCIL held on Tuesday 4<sup>th</sup> October 2022

Present: Chair Penny Rowe (PR), Vice Chair Judy Stephens (JS), Councillors Peter Champness (PC), Katie Vine (KV),

1. **Chairman's Welcome and Public Participation.** PR welcomed the Councillors to the meeting, there were no members of the public in attendance. PR advised this meeting has been advertised as a public meeting and as such could be filmed or recorded by broadcasters, the media or members of the public. KP confirmed the meeting was not being recorded.

6. **Chairman's Report.** PR thanked the Clerk for informing the parishioners of the proclamation of the new King held on the grounds of St Winnow Church and thanked Frank and Stephanie for their hospitality.
7. **Reports from Outside Organisations.**
  - a) **Devon & Cornwall Police.** An Email had been received from PCSO SC - From 01/09/22 – 30/09/22 there were 7 various crimes, 5 of which occurred at Bodmin Parkway Station. The 2 locally were a criminal damage and a public order offence. Numerous patrols have been conducted around the Parish and all was found to be in order. If there are any questions or matters arising for my attention, then please contact me in the usual manner.
  - b) **Cornwall Council.** CM apologised for not attending the proclamation.  
CM reported he is supporting the Action A390 campaign which is a similar cause to the Safe 38 campaign. There have been a run of serious and fatal accidents along the A390 between St Blazey and Taphouse. CM is campaigning for average speed cameras along this stretch of road as a starter and invites people to join the Action A390 facebook page to raise awareness and encourage members. They need to identify danger spots with practical Solutions and join communities together to be able to approach Cornwall Council as a larger body.  
Social Care is still in peril. Patients are unable to be discharged as there are no care homes with any room available.  
CM made the Councillors aware Cornwall Council were looking into closing down Tolvaddon control centre and moving it nationwide.  
The Mayor of Cornwall debate: The promise from the last government was more money and power for local areas to do more for themselves but need accountability, this may change as we are now under a new, government.
