- 7. Reports from Outside Organisations.**
 - a) Devon & Cornwall Police. A report was sent by email: From 01/06/23 – 30/06/23 there was 1 crime that of criminal damage where a car windscreen has been scratched. CCTV coverage has been shared locally but no positive identification was obtained however one potential suspect was suggested and a family member has been spoken to. Please be mindful of the recent illegal landing of migrants in South Devon and report any suspicious incidents on or near to the river straightaway quoting OP KRAKEN. Remain vigilant as recently we had another spate of rural/farm thefts and burglaries. Again report any suspicious incidents or vehicles. Numerous patrols have been conducted around the Parish and all was found to be in order.

- 8. Planning Applications.**
 1. PA23/04663 – Rivermead - Tree works within a Conservation Area: Removal of a group of three very large fir trees in the garden. There were no objects to this application.
- 9. Planning Results.**
 - I. PA23/02474 - Land North West of Harvest Barn – Conversion and extension to stable building to create a single dwelling house without compliance with condition 2 of decision notice PA19/05753 dated 06.09.2019. Pending
- 10. Grant Funding, Applications & use of Funds.** To discuss a Defibrillator at St Winnow and access to electricity. KP to find out the rough cost of electricity and chase St winnow Church for a location.
- 11. Neighbourhood Plan.** An update on proceedings. JS is getting down to the nitty gritty of policies with PR and will have them ready for the next meeting to discuss.

12. Common Land CL04/CL05. To discuss the upkeep and safety of the area, benches & Oak Posts. All benches are in excellent condition with no damage. The small jetty is currently inaccessible.

13. To review the Ice & Snow Plan. The salt/grit is currently kept at Manelley Farm in St Veep and is available for both parishes, St Veep & St Winnow. This is a very large area for one farmer to cover and a second store should be sought within St Winnow Parish. – KP to look into the cost of grit.

14. Lerryn School – with numbers dwindling the school is in danger of closing down. PR reported the Red Store are looking into crowd funding to help. JS proposed we consider donating £5000, from our community fund, this was seconded by SC with all Councillors present in favour. JS to look into it further.

15.2 Speed Limit between Middle Taphouse and St Winnow School. – Needs a 50 limit sign also a sign at Middle Taphouse from the junction opposite the Trago cut through. Repeaters needed all along this road!
